MINUTES OF THE 192th MEETING OF THE REVIEW COMMITTEE ON GENETIC MANIPULATION (RCGM) HELD ON 29.10.2020 BY VIDEO CONFERENCING

The Chairman, RCGM extended a formal welcome to the members of the RCGM for the 192th meeting and initiated the process of the meeting. The list of participants is given at Annexure-I.

- 2. The Committee adopted the minutes and recommendations of the 191th meeting of the RCGM held on 15.10.2020.
- 3. On action taken report, the Member-Secretary informed that during the 191thmeeting of the RCGM, a total of 23 applications including information items were considered and the Secretariat is in the process of issuing requisite permit letters based on the recommendations of the RCGM.

4. Proposals considered

4.1 Applications in the area of pharmaceuticals

The Committee considered applications to import recombinant vectors expressing Spike protein of SARS-CoV-2, SARS-CoV-2 isolate, recombinant *E. coli*, novel chimeric antigen receptor lentiviral vector, GMO clone expressing HBsAg VLP, recombinant *Komagataella phaffii* carrying a gene of SARS-CoV2; to transfer different components of COVID-19 liquid vaccine; to receive; to conduct preclinical toxicity studies on COVID-19 vaccine Drug product, Rituximab biosimilar; pre-clinical toxicity study reports on Inactivated Hepatitis A Vaccine; waiver of Pre-clinical studies on Anakinra biosimilar to be used in moderate to severely affected cases of Covid19, mRNA vaccine candidate HGCO19 for COVID-19. After deliberation on each application including information items, appropriate decision was taken by the RCGM.

4.2 Applications in the area of Agriculture

The Committee considered applications to import mutant lines of *Arabidopsis thaliana*; reports on event selection trial of GE *Brassica juncea* lines. After deliberation on each application including information items, appropriate decision was taken by the RCGM.

5. IBSC Reports

The Committee considered minutes submitted by fifteen IBSCs, appropriate decision was taken by the RCGM.

6. Other items

The Committee discussed on request submitted by GEAC on genome edited plants, and appropriate decision was taken by the RCGM.

No other transaction took place and the meeting ended with vote of thanks to the chair.
