- a) Translational Health Science and Technology Institute (THSTI) is an autonomous institute of the Department of Biotechnology (DBT), Ministry of Science & Technology, Government of India. THSTI is a part of the interdisciplinary Biotechnology Science Cluster at Faridabad, Haryana in the National Capital Region (NCR). The institution is a dynamic enterprise with a mission to conduct innovative translational research and to develop research collaborations across disciplines and professions to translate concepts into products to improve human health.
- b) THSTI has built several inter-institutional collaborations and connectivity with industry supported by well-trained teams of research and laboratory staff. THSTI has established various centres namely (a) Centre for Maternal and child health, (b) Centre for Virology, Therapeutics and Vaccines (c) Centre for Tuberculosis research (d) Centre for Human Microbiome research, (e) Centre for bacterial diseases and anti-microbial resistance research (f) Centre for Immunobiology and Immunotherapy (g) Centre for Drug design and Discovery (h) Clinical Development Services Agency (i) Computational and Mathematical Biology Centre (j) Centre for Bio-design. These centres are strengthened by many core facilities viz. Bioassay Laboratory, Biorepository, Biosafety Level-3 Lab, Data Management Centre, Immunology Core laboratory, Multi-OMICS facility, Experimental Animal Facility, Vaccine design and Development facility etc that serve as huge resources for the research programmes of THSTI, and also the National Capital Region Biotech Science Cluster and other academic and industrial partners
- **c)** Applications are invited from eligible candidates who are Indian nationals / persons with OCI status to fill up one post of Professor.
- **d) Method of appointment**: Direct recruitment failing which by Deputation/Absorption.

e) Eligibility Criteria:

f) Compensation:

- In addition to the usual pay & allowances as admissible, the selected incumbent will be entitled to other benefits such as a semi-furnished on-campus housing (in lieu of HRA), medical reimbursement, telephone expenses reimbursement, newspaper allowance, children education allowance, Leave Travel Concession, New Pension Scheme contribution, transport allowance, support for national and international conference etc. as per the Government of India rules.
- 2. Non-Practicing Allowance (as admissible).

g) Other benefits:

- 1. The incumbent will mentor other scientists / post-doctoral fellows / Ph.D. students.
- 2. The incumbent will be encouraged to generate extramural funding from various Government and non-government funding agencies.
- 3. The incumbent will have access to state of the art technologies available with the Institute and research leads from other related centres of THSTI and other Institutions.
- 4. The incumbent will be permitted to undertake consultancy services on behalf of the institute and retain a percentage of the consultancy fees as per the Bye-laws of the institute.

h) General Terms and conditions:

1. All educational, professional and technical qualification should be from a recognized Board/University.

- 2. Deputation will be governed as per rules of deputation of GOI as amended from time to time.
- 3. Persons working in Govt. / PSUs / autonomous bodies should apply through proper channel or produce a relevant 'No Objection Certificate' while appearing in the selection process failing which their candidature will be cancelled.
- 4. The experience requirement specified above shall be the experience acquired after obtaining the minimum educational qualifications specified for the post. The candidates are required to satisfy themselves before applying that they possess at least the essential qualifications laid down for the post. No enquiry asking for advice as to eligibility will be entertained.
- 5. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for interview/presentation.
- 6. If any document/ certificate furnished is in a language other than Hindi or English, a transcript of the same in English duly attested by a Gazetted officer or notary is to be uploaded.
- 7. Closing date of online application will be the CRUCIAL DATE for determining eligibility with regard to age, essential qualification etc.
- 8. Although the above position is not reserved for the Persons with benchmark disabilities (PwBD) but the position has been identified as suitable for them under following categories:
 - (i) Locomotor disability OA, OL, OAL including leprosy cured, dwarfism and acid attack victims
 - (ii) Hard of hearing (HH)
 - (iii) Low vision (LV)
 - (iv) multiple disabilities from amongst persons under clauses (i) to (iii) excluding deaf-blindness
- 9. Age and other relaxations for direct recruits, departmental candidates and THSTI employees:

i	Ex-servicemen (ESM)	5 years provided they have rendered at least 5 years military service
ii	Central Government servants	5 years provided they have rendered at least three years continuous services (does not apply to persons working with CPSU, CPSE, CAB etc)

- 9 Age relaxation as per government norms will be provided duly ensuring at least 5 years remaining service for superannuation (60 years).
- 10 Number of positions to be filled will be as per the Institute's need and availability of the suitable candidates.
- 11 In case a large number of applications are received, screening will be done to limit the number of candidates to those possessing higher/relevant qualification and experience.
- 12 Only shortlisted candidates will be called for selection process.
- 13 All results/notifications will only be published on our website. Therefore, the candidates should visit THSTI website regularly.
- 14 All future communications related to the selection process, will only be made through email.

- 15 With regard to any provisions not covered in this notification, the bye laws of THSTI / Govt. of India rules / quidelines shall prevail.
- 16 Canvassing/providing false information in any form will be a disqualification.

 - Forwarding letter / NOC from the current employer in the case of candidates working in Govt. / PSUs / autonomous bodies
