The National Institute of Immunology is an autonomous institution supported by the Department of Biotechnology, Government of India. The Institute is committed to advance research addressing the basic mechanisms involved in body's defenses, host-pathogen interactions and related areas. The Institute follows a two-pronged strategy of linking excellence in rigorous fundamental research with pragmatic pursuit of emerging application possibilities in entrepreneurial partnerships. The current research interests at the Institute coalesce into four broad areas: Gene Regulation, Immunity & Infection, Molecular Design, and Reproduction & Development.

The Institute is seeking applications from eligible candidates for filling one vacancy of Staff Scientist-VIII / Deputy Director in the HAG scale of Rs 67000 (Annual increment @ 3%) – 79000/-with usual allowances as per the Government of India rules, to be selected on a competitive basis.

Qualifications:

- (1) Essential (a) Ph.D / MD or equivalent in any branch of modern biology / medical sciences:
 - (b) outstanding academic and scientific credentials as reflected from the publications in high quality journals; (c) proven leadership abilities with multi-disciplinary approach to modern biology addressing immunological problems; (d) 15 years of minimum research experience as Principal Investigator in any National Institution/R&D Laboratory / University.
- (2) Desirable (a) experience of managing academic programmes at Ph.D. level; (b) administrative skills appropriate for scientific organization; (c) experience of interaction with National/ International institutions/ Organizations involved in promotion of scientific research (d) recognition of scientific contributions by at least two Scientific Academies or election to prestigious professional societies /forums.

Besides the scientific and academic activities, the incumbent appointed against this post has to assist the Director in a wide range of activities of the Institute.

The age limit is below 55 years which is relaxable in respect of candidates belonging to reserved categories in accordance with GoI orders. There would be no upper age limit in respect of scientists already working on regular basis in NII. Besides this, the age limit, qualifications and other requirements in case of candidates otherwise qualified may be relaxed by the Competent Authority. The appointment will be on contract basis initially for a period of five years or till attaining the age of superannuation, whichever is earlier. At the end of four years of service the candidate's performance will be assessed by an Assessment Committee for regular appointment on completion of five years contract service or otherwise.
