# Applications / Nominations are invited for the post of Executive Director Translational Health Science and Technology Institute

1 The Department of Biotechnology (DBT), Ministry of Science & Technology (Government of India) has established the Translational Health Science and Technology Institute (THSTI), an autonomous institution, as a part of the interdisciplinary Biotech Science Cluster at Faridabad in the National Capital Region. The Institute is a dynamic, interactive organization with a mission to conduct innovative translational research and to develop research collaborations across disciplines and professions to translate concepts into tangible products to improve human health.

THSTI has built several inter-institutional collaborations and connectivity with industry supported by well-trained teams of research and laboratory staff. THSTI has established various centres namely (a) Centre for Maternal and Child Health, (b) Centre for Virology, Therapeutics and Vaccines (c) Centre for Tuberculosis Research (d) Centre for Human Microbiome research, (e) Centre for Bacterial Diseases and Anti-Microbial Resistance Research (f) Centre for Immunobiology and Immunotherapy (g) Centre for Drug Design and Discovery (h) Clinical Development Services Agency (i) Computational and Mathematical Biology Centre (j) Centre for Bio-design . These centres are strengthened by many core facilities viz. Bioassay Laboratory, Biorepository, Biosafety Level -3 Lab, Data Management Centre, Immunology Core laboratory, Multi-OMICS facility, Experimental Animal Facility, Vaccine design and Development facility etc that serve as huge resources for the research programmes of THSTI and also the National Capital Region Biotech Science Cluster and other academic and industrial partners.

### 2. Details of the post of Executive Director

- 2.1 We are looking for a leader at the level of **Executive Director** on deputation (including short term contract) / absorption
- 2.2 The position of **Executive Director** offers a unique opportunity for the right individual in providing strong and visionary leadership to the institution. He/she will perform duties of the Chief Executive Officer of the Institution and the responsibilities of ED include leading and nurturing the core multi-disciplinary research faculty, developing policies and fostering collaboration with scientific, medical and engineering partner institutions, developing mechanism for collaboration with industry, recruitment of appropriate faculty and management of the extramural activities including supporting research resource units in other institutes.

- 2.3 The ED of THSTI will report to the Governing Body and will be responsible for implementation of the decisions taken by the Governing Body.
- 2.4 The selected incumbent will be placed on the Pay Level 17 in the Pay matrix as per CCS (Revised Pay) Rules, 2016.

## 3. Eligibility Criteria

Scientists from Central / State Govt., Research Institutes, Autonomous Bodies Government funded research organisations / institutes etc. subject to the fulfilment of the following conditions (a) and (b):-

(a) Holding analogous post on regular basis in the parent department;

Or,

With five years' service in a post in Pay Level 14 or equivalent in the parent cadre/ Department.

(b) Possessing the qualification & experience as given below:

### Essential:

- i) MD /PhD or equivalent degree in biomedical sciences,
- ii) Minimum 15 years' of research experience in the field of specialization and have aptitude for translational research,
- iii) Excellent track record, hand in publications, patent and awards.

### Desirable:

- i) Experience in successfully running large programs, centre or institution
- ii) Experience in guiding research activities in the area of specialisation.

### 4. Age limit and tenure of appointment

The period of deputation including period of deputation in other ex-cadre posts, held immediately preceding this appointment in the same or some other organisation/ Department should ordinarily not exceed 5 years. The maximum age limit for the appointment on deputation (ISTC) should not exceed 58 years as on the closing date of the receipt of the applications.
