# APPLICATIONS / NOMINATIONS ARE INVITED FOR THE POST OF DIRECTOR, INSTITUTE OF BIORESOURCES AND SUSTAINABLE DEVELOPMENT (IBSD), IMPHAL, MANIPUR, INDIA

Realizing the importance and potential of the rich and unique Bioresources of North Eastern Region (under Indo-Burma biodiversity hotspots) of the country for socio-economic growth of the region, Institute of Bioresources and Sustainable Development (IBSD) was set up by Department of Biotechnology (DBT) at Imphal, Manipur in 2001 with an objective to develop and utilize rich bioresources of North-East Region of the country through the application of modern tools of biology and biotechnology. The IBSD has been carrying out research in the areas of Medicinal Plants and Horticultural Resources, Microbial Resources, Animal Resources and Bioinformatics and related areas. IBSD has established its Regional Centre in Gangtok, Sikkim with an aim of sustainable development and utilization of bioresources of the Eastern Himalayas along with expanding its outreach activities in the states of Meghalaya and Mizoram. Applications are invited from eminent scientists [Indian National, NRI / OCI / PIO\* (\*see note)] having proven scientific record in modern biology / life sciences as evident through proven ability to carry independent research and provide leadership for research in emerging areas of Bioresources along with possessing excellent leadership ability for the position of Director, IBSD on deputation (including short-term contact) / absorption basis. The position of Director offers a unique opportunity for the individual to provide strong and visionary leadership to the institution. The Director is the Chief Executive of the institute and shall be responsible for leading and nurturing the core multi-disciplinary faculty, developing research policy, developing and promoting collaborations with partner institutes and industry besides proper administration of the affairs of the Institute. The applicants must have a holistic vision and be capable of providing leadership of different areas of Bioresources, especially where IBSD has already made significant impact.
- Scale of Pay and other benefits: The selected incumbent will be placed in the Level-14 (Pay Matrix: ₹ 1,44,200-2,18,200/- as per 7<sup>th</sup> CPC). Other benefits / allowances shall be as per rules applicable for appointment on deputation including short-term contact / absorption basis.

#### 4. Eligibility Criteria:

- 4.1 Scientists from Central / State Governments, Research Institutes, Autonomous Bodies, Government funded Research Organizations / Institutes, etc.
- 4.2 Holding analogous post on regular basis in the parent Department; or
- 4.3 With 2/3 years service in post with Grade Pay of Rs. 8900/Rs. 8700 respectively or equivalent in the parent cadre/Department and possess the qualification & experience as below:-

## **Essential:**

- i) Ph.D. in any life science discipline/M.D or equivalent.
- ii) Minimum 15 years of experience of research in the area of specialization.
- iii) Excellent track record, excellent scientific publications, patent and awards.

#### Desirable:

- i) Experience in successfully running large programme, centre, institution.
- ii) Experience of guiding research activities in the area of specialization.
- 5. Age limit and tenure of appointment: The period of deputation includes period of deputation in other ex-cadre posts, held immediately preceding this appointment in the same or some other organizations / Department should ordinarily not exceed 5 years. The maximum age limit for appointment on deputation (ISTC) should not exceed 58 years as on the closing date of receipt of applications.
