- 1. Short title and commencement.- (1) These rules may be called the Ministry of Science and Technology, Department of Biotechnology, Junior Analyst (Technical) (Group 'B' Gazetted, Non-Ministerial) Amendment Rules, 2024.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Ministry of Science and Technology, Department of Biotechnology, Junior Analyst (Technical) (Group 'B' Gazetted, Non-Ministerial) Recruitment Rules, 2012 (herein after referred to as the said rules):
- (i) For Rule 6, under column 2 (Number of post), the following shall be substituted, namely.—
 - (a) 12*(2024)

 *Subject to variation dependent on workload.
- (ii) For Rule 6, under column 10 (Method of recruitment whether by direct recruitment or by promotion or by deputation/absorption and percentage of vacancies to be filled by various methods), the following shall be substituted, namely.—
 - (a) Hundred percent by promotion failing which by deputation.
