About the Organization:

The DBT/Wellcome Trust India Alliance (India Alliance) is a co-funded partnership between the Department of Biotechnology, Government of India and The Wellcome Trust, UK to support a Biomedical Research Career Program (BRCP). It is registered as an independent public charity in India. See www.indiaalliance.org for details.

The partnership was first setup in 2008-09 for a period of ten years, which was subsequently extended for another five years from FY 2019-20 (Phase-II). The stated mission of India Alliance during its second phase (FY 2019-20 to 2023-24) is to "enable biomedical research in India through funding and engagement". This includes –

- *Empowering Researchers* to be internationally competitive and become future leaders in India.
- Bridging Gaps in research management, and between science and society
- Striving for Excellence through diversity, inclusivity, and transparency in science

During this time, India Alliance awarded ~280 fellowships and grants to researchers at different career stages, based at 115 different institutions in 47 Indian cities. It also committed about INR 790 Crore towards the fellowships and grants and associated activities.

India Alliance has become a valued research funder in India due to the rigor and transparency in its selections, the flexibility and timeliness of its funding, and its engagement with applicants and awardees. It has created an unprecedented opportunity for biomedical researchers in India to address challenging problems and compete globally. Many of the funded researchers have made important contributions ranging from basic science that increased the knowledge base on a biological system or disease, to clinical research that directly tested interventions on human patients, and public health researchers who carried out pioneering population-based studies. Some studies have also led to new treatments and changes to health policy. Many fellows have also gone on to take on leadership positions.

Scope of Work

Impact Assessment

Going forward, the Department of Biotechnology (DBT) and the Wellcome Trust intends to continue the partnership and support Biomedical Research Career Programme (BRCP).

The BRCP programme over the years has delivered noteworthy success. However, to gain a thorough understanding of the impact of the programme on scientific research and development ecosystem in the country both the parties have decided to conduct an independent, cost benefit analysis assessment (combining qualitative and quantitative approach), which should be accomplished in stipulated timeframe (max. three months).

This evaluation should be updated and build from the previous independent assessment conducted in 2019.

Scope and Objectives

The scope of this independent evaluation is to conduct a review of the India Alliance, based on: (1) the following parameters and, (2) the following method of evaluation.

Proposed themes and parameters for evaluation

- 1. Award Selection Process and Programme Attractiveness -Assessment of award selection process, feedback from awardees, comparison with similar national and international award processes, Impact on career progression and competitiveness, geographical distribution, gender balance, etc
- 2. Comparative Analysis of Funding Agency Benchmarking and comparison with other public and private funding agencies. Effects on other Life Sciences funders public and private.
- 3. Policy and Practice Comparative analysis, Review mechanisms, Effects on health policy and practice, complementarity with other national programs, research ecosystem development, etc.
- 4. Achievement of outcomes Impact on biomedical and biological science research ecosystem in India and other collateral impact, Targeted outcomes, global standing, capacity development, etc.
- 5. Advancement of Science/knowledge parameters Effects on scientific breadth and depth, Analysis of scientific productivity including quality of publications,

- comparison with other similar awards, scientific recognition, translational impact of the work, etc.
- 6. Citation Rate The citation rate of research funded by India Alliance, comparative analysis with similar national programs, global competitiveness etc.
- 7. Human resource and Leadership Development Effects on capacity development; the "ripple effect" of funding, Prospect of employment, Mentoring, etc Empowerment of awardees for becoming leaders, career evolution, follow-on funding, etc.
- 8. Collaborative and Interdisciplinary Research Networks— Collaborative and Interdisciplinary Research Networks, International collaborations, Interaction of basic and clinical researchers. Engagement with industry, etc.
- 9. Institutional and sector analysis: w.r.t funds/publications.
- 10. Public Awareness Science outreach and science communication, Engagement in education/training activities, Engagement with the public; more aware and engaged public, social media presence, etc.
- 11. Cost-benefit analysis and any other allied impact from a socio-economic/techno-scientific perspective, Finance management.
- 12. Spillover effect on Sustainable Development Goals (SDGs) and National Development Programmes (NDPs).
- 13. Efficiency in the fund disbursal process: issues on the timely disbursal of fellowships by IA from the due date.

Mode of evaluation:

- 1. The impact assessment study will follow a mixed method approach, involving both quantitative and qualitative methods. The agency will collect quantitative data by administering survey questionnaires tailored to each sub-scheme and stakeholders' population and qualitative data will be gathered through instruments finalized in consultation with the DBT and IA.
- 2. Agency has to obtain a legal / compliance clearance for the study from the competent authority (board).
- 3. Analysis should be based on several lines of evidence: bibliometric analysis, surveys, interviews, case studies, etc. of at least 10% of fellows and a significant number of other stakeholders.
- 4. Every aspect of analysis should be comparative and with preapproved programs of other agencies.
- 5. Efforts should be made to avoid cognitive biases.
- 6. The agency has to pre-define Performance indicators, Performance Standards, and benchmarking criteria.
- 7. Expose areas where improvement is needed, reveal underlying problems, offer pragmatic solutions within the institutional mandate and framework. Establish the links/identify gaps between processes and results.
- 8. To evaluate the strength, weakness, opportunities, and threats of the programmes evaluated in general and particular to sub schemes.

Formats for submission

Organizations expressing their interest should share a detailed proposal (word and/or ppt). In addition, they should provide the following details:

- 1. Organizational and contact details (individual Consultants need not apply)
- 2. Prior experience of the organization in reviewing program within Indian research ecosystem
- 3. Reports of prior work
- 4. List of experts/consultants on the payroll and their qualifications
- 5. Financial health of the organization

The proposal, along with supporting documentation, should be emailed to ceo@indiaalliance.org and/or by post /courier so as to reach latest by **EOD 12/09/2023**.

Shortlisted organizations will be invited for a presentation in the **third week of September.**

The decision to shortlist the firms shall be taken by the <u>concerned committee</u> and shall be final and binding on all concerned.
