II. JOB DESCRIPTION & RESPONSIBILITIES: The Managing Director is the Chief Executive of the Corporation and accountable to its Board of Directors and Government of India/Shareholders. He/ She is responsible for the efficient functioning of the Corporation, and for achieving its corporate objectives and performance parameters.

III. ELIGIBILITY
