#### Applications/Nominations invited for the Post of Dean, THSTI

- a) Translational Health Science and Technology Institute (THSTI) is an autonomous institute of the Department of Biotechnology (DBT), Ministry of Science & Technology, Government of India. THSTI is a part of the interdisciplinary Biotechnology Science Cluster at Faridabad, Haryana in the National Capital Region (NCR). The institution is designed to be a dynamic enterprise with a mission to conduct innovative translational research and to develop research collaborations across disciplines and professions to translate concepts into products to improve human health.
- b) THSTI has built several inter-institutional collaborations and connectivity with industry supported by well-trained teams of research and laboratory staff. This foundation has helped pursuit of thematic research programmes which can be broadly categorized as, (a) Infectious diseases and Immunology (b) Maternal and Child Health, (c) Non communicable disease d) Multidisciplinary clinical and translational research. These will be strengthened by four core facilities viz. Small Animal Facility, Data Management Center, Biorepository and Bioassay Laboratory that will serve not only the research programmes of THSTI, but also the National Capital Region Biotech Science Cluster and other academic and industrial partners.
- c) We are looking for leaders to fill up two positions of Dean. The actual number of positions that will be filled will depend upon identification of suitable candidates.
- d) The Dean will be the administrative head/mentor of the thematic research programs as mentioned above and may be delegated additional supervisory responsibilities of academics/ students affair/ campus matters/ international relationships/ etc. The Dean of THSTI will report to the Executive Director.

#### e) Eligibility Criteria:

#### I) For Direct Recruitment:

- i) Essential Qualification: PhD in Life Sciences or MD or MVSc or MTech in Biotechnology/Biomedical Engineering/Biotech Pharmacology or relevant area from a recognised University with minimum 15 years relevant experience in responsible higher position in research/teaching Institute/University/Industry with published research of highest standards and/or technologies of established utility.
- **ii) a) Desirable:** At least two years' experience as a head of a department in a reputed academic or research institute or industry in related fields. Demonstrated ability to create new knowledge in the area of expertise or translate innovations to develop new processes or products and ability to network with national and global institutes and industries.

**b)** Since the responsibilities of one position of Dean would be related to Clinical Research, basic degree in MBBS / BDS / BVSc and minimum 15 years' experience in clinical research or related areas would be desirable.

**iii)** The experience requirement specified above shall be the experience acquired after obtaining the minimum educational qualifications specified for the post.

#### II) For Deputation:

Officials of the Central Government/ State Government/ Universities/ Public Sector Undertakings and Government funded research organisations/ institutes possessing the qualifications and experience prescribed for direct recruitment are eligible to apply. The terms and conditions of deputation shall be governed by DoPT OM No. 6/8/2009-Estt. (Pay II) dated 17<sup>th</sup> June 2010 as amended/ revised from time to time.

#### f) Age limit, Method of appointment and Probation:

- i. Age limit for direct recruitment: 55 years as on the last date for receipt of application.
- ii. Age limit for deputation : 58 years as on the last date for receipt of application
- **iii.** Method of appointment: Deputation/Absorption failing both by direct recruitment.
- **iv. Probation:** There will be an initial probation period of one year which may be extended at the discretion of the Competent Authority.

#### g) Compensation:

- i. The incumbent will be placed in Level 16 of the pay matrix with annual increment as per CCS (Revised Pay) Rules, 2016. At the present rate, a Dean shall be entitled for a gross pay of about Rs.3,00,000/- as per the CCS (RP) Rules, 2016.
- ii. In addition to the usual pay & allowances as admissible, the selected incumbent will be entitled to other benefits such as a semi – furnished on-campus housing (in lieu of HRA), medical reimbursement, telephone expenses reimbursement, newspaper allowance, children education allowance, Leave Travel Concession, New Pension Scheme contribution etc. as per the Government of India rules and a chauffeur driven car (in lieu of transport allowance).

#### iii. Other benefits:

- The incumbent will mentor other faculty members/scientists/post-doctoral fellows/ Ph.D. students.
- > The incumbent will be encouraged to generate extramural funding from various Government and non-government funding agencies.
- > The incumbent will have access to state of the art technologies available with the Institute and research leads from other related centres of THSTI and other Institutions.
