MINUTES OF THE 218th MEETING OF THE REVIEW COMMITTEE ON GENETIC MANIPULATION (RCGM) HELD ON 28.10.2021 BY VIDEO CONFERENCING

The Chairman, RCGM extended a formal welcome to the members of the RCGM for the 218th meeting and initiated the process of the meeting. The list of participants is given at Annexure-I.

- 2. The Committee adopted the minutes and recommendations of the 217th meeting of the RCGM held on 14.10.2021
- 3. On action taken report, the Member-Secretary informed that during the 217th meeting of the RCGM, a total of 43 applications including information items were considered and the Secretariat is in the process of issuing requisite permit letters based on the recommendations of the RCGM.

4. Proposals considered

4.1 Applications in the area of pharmaceuticals

The committee considered applications to import cells banks of HEK293, rAD26, and rAD5; transfer drug substance of Whole Inactivated Virus bulk of COVID-19 vaccine; request for extension of validity of approved permits regarding transfer of different components of recombinant adenovirus vector based COVID-19 vaccine; pre-clinical toxicity study reports on novel gene therapy product for Haemophillia B; progress report on data of handling of SARS-CoV-2 strain CDX-005 during vaccine manufacturing and characterization with change in required biosafety level from Enhanced BSL-2 to BSL-2. After deliberation on each application including information items, appropriate decisions were taken by the RCGM.

4.2 Applications in the area of Agriculture

The Committee considered applications to transfer GE banana lines; to conduct Event Selection confined field trials of GE banana lines; to conduct Biosafety Research Level-I confined field trials of GE cotton. After deliberation on each application including information items, appropriate decisions were taken by the RCGM.

5. IBSC Reports

The Committee considered minutes submitted by four IBSCs, nil annual compliance report and nil medical surveillance report, and appropriate decisions were taken by the RCGM.

6. Other items

The Committee deliberated on applications recommended by the Inter-Ministerial Committee and Draft Certificate for Certification of BSL-3 facility. Appropriate decision was taken by the RCGM.

No other transaction took place and the meeting ended with vote of thanks to the chair.
