

MINUTES OF THE 210th MEETING OF THE REVIEW COMMITTEE ON GENETIC MANIPULATION (RCGM) HELD ON 19.07.2021 BY VIDEO CONFERENCING

Dr. Alka Sharma, Advisor/Scientist 'G' DBT, and Head Regulation, DBT informed the RCGM regarding the amendment in the RCGM composition vide O.M dated 12.07.2021.

Dr. Alka Sharma welcomed the Chairman Prof. Y.K. Gupta. The Chairman, RCGM extended a formal welcome to the members of the RCGM for the 210th meeting and initiated the process of the meeting. The list of participants is given at Annexure-I.

2. The Committee adopted the minutes and recommendations of the 209th meeting of the RCGM held on 24.06.2021

3. On action taken report, the Member-Secretary informed that during the 209th meeting of the RCGM, a total of 46 applications including information items were considered and the Secretariat is in the process of issuing requisite permit letters based on the recommendations of the RCGM.

4. Proposals considered

4.1 Applications in the area of pharmaceuticals

The committee considered applications to import SARS-CoV-2 strain, South African SARS-CoV-2 COVID-19 reference strain, SARS-CoV-2 isolate, hCoV isolates, recombinant (Non-virulent) adenovirus, Lentiviral Vector aCD19CAR SF, SARS-CoV2 mutant strains, replication-incompetent adenovirus type 5 (Ad5) with chimeric CD40L as adjuvant; to receive SARS-CoV-2 strain; to transfer drug substance of Whole Inactivated Virus bulk of COVID-19 vaccine; pre-clinical toxicity study reports on SARS-COV-2 subunit vaccine; pre-clinical toxicity study of Tocilizumab biosimilar, Varicella Zoster Virus gE vaccine, Denosumab biosimilar. After deliberation on each application including information items, appropriate decisions were taken by the RCGM.

4.2 Applications in the area of Agriculture

The Committee considered information items and after deliberation, appropriate decisions were taken by the RCGM.

5. IBSC Reports

The Committee considered minutes submitted by eleven IBSCs, nil annual compliance reports and nil medical surveillance reports, and appropriate decisions were taken by the RCGM.


6. Other items
