MINUTES OF THE 211th MEETING OF THE REVIEW COMMITTEE ON GENETIC MANIPULATION (RCGM) HELD ON 22.07.2021 BY VIDEO CONFERENCING

4. Proposals considered

4.1 Applications in the area of pharmaceuticals

The committee considered applications to receive SARS-CoV-2 mutant strains; pre-clinical toxicity study ofrecombinant Anti VEGF Fragment Antibody; pre-clinical toxicity study reports on Pertuzumab biosimilars, Bevacizumab biosimilar, Ranibizumab biosimilar. After deliberation on each application including information items, appropriate decisions were taken by the RCGM.

4.2 Applications in the area of Agriculture

The Committee considered information item and after deliberation, appropriate decision was taken by the RCGM.

5. IBSC Reports

The Committee considered minutes submitted by twenty eight IBSCs, nil annual compliance reports and nil medical surveillance reports, and appropriate decisions were taken by the RCGM.

6. Other items

The Committee deliberated on draft list of microorganisms finalized by the Expert Committee constituted, vide OM dated 22.05.2020, to review & update risk groups of microorganisms under Risk Groups 1-4 of "Regulations and Guidelines on Biosafety of Recombinant DNA Research &Biocontainment, 2017". The committee also deliberated on the minimum qualification required for the Biosafety Officer to be inducted at the time of constitution of IBSC and on the requirement of submission of Compliance documents such as Annual Compliance reports for the year 2020 and Medical surveillance report on IBKP portal.

Appropriate decisions were taken by the RCGM.

The Minutes are approved.


